KEY STANDARD CONTRACT TERMS

PLAYER ACQUISITION	Overseas Player Draft and player retention processes, replacement players can be signed direct outside of this
TEAM SALARY CAP	USD 1.6m total payment pool per team, player minimum \$12.5k, no maximum
CONTRACT LENGTH	Generally contracted from signing until Oct 31, unilateral extension clause for a further 2 x 12 month periods under same conditions, players should be aware of prizemoney & bonus structures and of injury and non-selection reductions
PAYMENT DATES	20% by 10 days after first League Match, 60% by last League Match, 20% by 60 days post last League Match. 100% of prizemoney to be distributed to Squad within 60 days of last League Match
TERMINATION RIGHT IN EVENT OF INJURY	Contract is subject to passing a fitness test on arrival, fee reduced pro rata based on availability as a percentage of total number of matches (including finals if applicable)
TERMINATION RIGHTS – OTHER	Gross misconduct or criminal conviction

INSURANCE PROVISIONS

PRIVATE MEDICAL COVER	Team to maintain medical insurance cover in relation to Player Injuries covering cost of emergency treatment and continuing treatment until repatriation (up to 3 months)
PTD FROM CRICKET COVER	No insurance details have been received
PTD FROM ANY OCCUPATION	No insurance details have been received
ACCIDENTAL DEATH	No insurance details have been received

PLAYER COMMERCIAL RIGHTS SUMMARY

STRUCTURE	Exchanged via Player Contract to team and BCCI, no specified fee allocated for commercial rights
APPEARANCES	12 (6 hours max for each appearance) – team has ability to reduce player fee by 5% per refused appearance. Players can be asked to undertake appearances outside of the Season
USE OF IMAGE	Team may use individual imagery where there is no implied individual association (at all other times must use with a min. 2 other players). Always in team kit in capacity of an IPL cricketer
BACK OF BAT BRANDING	Player owned, 10in2 permitted in addition to manufacturer – not conflicting with primary partner or lead competition partner, helmet remains a team asset unless Player wishes to wear their own due to safety issues
PERSONAL ENDORSEMENTS RESTRICTIONS	Any appearances / promotions for new endorsements cannot conflict with league or team partners during competition period, existing endorsements cannot be promoted on match days
