It's important your commercial rights (e.g. Name, Image, Likeness) are protected from unauthorised use and you get a say and compensation where they are featured:

- **Globally** - The WCA Global Commercial Program was established to do exactly that and now features over 700 men's and women's international players across 17 countries through WCA's partnership with **Winners Alliance** - Contact cameron@theworldca.com for more information
- **Domestically in Leagues** - Players may sign certain commercial rights across to the Leagues through their player contracts. This includes, for example, player appearances and use of attributes by major sponsors, for game promotion and as part of certain licensed products.
